# **Results: corporate bond repo transactions**

- Today, Banxico offered credit institutions the facility to enter into corporate securities repo operations with a maturity of up to 91 days for a maximum amount of MXN 100 billion (US\$ 4.5 billion)
- The settlement date will be on Monday, July 6<sup>th</sup>
- The results of the transactions were:
  - Three bids were received by two participants with an 5.0% YTM for an amount of MXN 100 million (US\$ 4.5 million)
- Broadly speaking, these operations experienced a weak demand. Nevertheless, we expect a higher level of participation as these operations might preserve the best liquidity conditions of the financial system.
