

Results: Corporate bond repo transactions

- Today, Banxico offered credit institutions the facility to enter into corporate securities repo operations with a maturity of up to 91 days for a maximum amount of MXN 90.65 billion (US\$ 4.0 billion)
- The settlement date will be on Monday, August 10th
- The results of the transactions were:
 - Three bids were received by two participants with an 5.0% YTM for an amount of MXN 630 million (US\$ 28 million)
- Broadly speaking, these operations experienced a lower demand despite the adjustments announced by Banxico last July 15th, 2020, in order to preserve the best liquidity conditions of the financial system. 
