# **Results: Corporate bond repo transactions**

- Today, Banxico offered credit institutions the facility to enter into corporate securities repo operations with a maturity of up to 91 days for a maximum amount of MXN 57.37 billion (US\$ 2.9 billion)
- No bids were received from market participants
- Broadly speaking, these operations have experienced a weak demand despite the adjustments announced by Banxico last July 15th, 2020, in order to preserve the best liquidity conditions of the financial system. - Banco de México announced the extension to liquidity and credit measures first announced on April 2020, until September 2021. We should remember that these had already been extended last September 2020


