- Today, Banxico offered credit institutions the facility to enter into corporate securities repo operations with a maturity of up to 91 days for a maximum amount of MXN 27.9 billion (US\$ 1.4 billion)
- No bids were received from market participants
- Broadly speaking, these operations have experienced a weak demand despite
 the <u>adjustments announced by Banxico last July 15th, 2020</u>, in order to
 preserve the best liquidity conditions of the financial system. For details of


