Flash: Will propose a dividend with a 4.6% yield

Pinfra announced that at its Annual Ordinary Shareholders' Meeting to be held on January 26, 2022, a cash dividend of MXN 7.2976 per share will be proposed, representing a 4.6% yield at current price levels.

Positive Implication: We consider this news as favorable, which we believe is due to a solid recovery in company's results. In this way, the interesting dividend yield, the expectation of good growth and higher cash flow generation in the year, as well as an attractive valuation (current 7.9x FV/EBITDA vs. 9.5x L3Y average), makes us maintain our positive vision for the company.
