

## **Citibanamex Survey – Pickup in inflation due to the end of summer discounts in electricity tariffs**

- Citibanamex just published its bi-weekly survey of economic expectations
- Economists expect headline inflation at 0.63% 2w/2w in the first half of October, practically in line with our 0.62% 2w/2w forecast, while the core component is expected at 0.19% 2w/2w, marginally above our 0.17% 2w/2w estimate
- For year-end inflation, economists now expect it to close 2017 at 6.23%, below both the previous estimate (6.3%) and our forecast (6.4%)
- Core inflation by YE17 is forecasted at 4.9%, in line with our forecast
- Regarding monetary policy, economists consensus continues to signal that Banxico's next rate movement will be a 25pb rate cut during a meeting taking place in August 2018
- One analyst still predicts a rate hike in December 2017, while the remaining economists forecast cuts as early as February 2018, although most expect it on the second half of the year (Banorte-Ixe: -50bp in August)
- Only one of the analysts expects the rate cut to take place in 2019
- For 2017, analysts expect an economic expansion of 2% yoy, above our 1.9% estimate (previous: 2.1%)
- Moreover, growth in 2018 is still expected at 2.2%, below our 2.5% forecast
- Finally, analysts expect the exchange rate at USD/MXN 18.50 by YE17 (Banorte-Ixe: USD/MXN 18.10), while the forecast for YE18 stands at USD/MXN 18.05 (Banorte-Ixe: USD/MXN 18.60)
